## **Budget/County**

- FY26 Budget in the approval process. Spotify was not approved.
- New building update Ms. Perrone and Ms. Bartholow attend biweekly meetings with County staff and the construction company. Anticipating completion in June. We will be required to use a state preferred moving company.

#### Legislation

Ms. Perrone directed the board members to the separate handout that highlights election bills that were passed by the General Assembly, and she reviewed each bill.

### Legislation Passed 2025 General Assembly:

- HB0041/SB0267 Election Law Petitions for the Formation of a New Political Party – Process – This is a departmental bill introduced by the State Board of Elections (SBE). It clarifies the deadlines for new political parties to submit a petition to SBE. Effective Date: 7/1/2025 – The deadline is changed from August 1<sup>st</sup> to July 1<sup>st</sup> for Third Party Petitions.
- HB0199/SB0257 *Election Law Notice to Permanent Absentee Voters* This bill is a departmental bill introduced by SBE. Effective Date: 7/1/2025 -Requires SBE to contact permanent mail-in voters at least 120 days before each election with a notification to remind the voter that they are getting a mail-in ballot and should include instructions how the voter can cancel the permanent mail-in ballot.
- HB0412/SB0337 Elections Local Boards of Elections and Boards of Canvassers *Open Meeting Requirements (Local Boards of Elections Transparency Act)* –Effective Date: 6/1/2025 – Requires livestreaming the monthly board meetings.
- HB0426/SB0313 *Postelection Tabulation Audits Risk Limiting Audits –* Effective Date 6/1/2025 Requires local boards to perform a Risk Limiting Audit prior to State certification after each primary and general election.
- HB0983/SB0685 *Local Boards of Elections Language Related Assistance* Effective Date: 10/1/2025 This gives SBE the right to require LBE's to translate forms and other voting materials into other languages.
- HB0274/SB0259 Election Law Local Boards of Elections Election Plan Requirements – This is a departmental bill introduced by SBE. Effective Date: 7/1/2025 - Allows local boards to submit one plan prior to each primary election. The plan will include ballot drop box locations, early voting centers, and polling place locations. This bill also eliminates 2018 as the baseline number of polling places.
- HB0945/SB0645 Election Law Gubernatorial Primary Election Date Effective: 10/1/2025 – Changes the date of the gubernatorial primary election from the last Tuesday of June to the 4<sup>th</sup> Tuesday in June. The date of the 2026 Gubernatorial Election will be Tuesday, June 23, 2026.
- HB0322/SB0088 *State Administrator of Elections Municipals Elections emergency (Muni elections) –* This is an emergency departmental bill introduced by SBE. Effective Date: Emergency This allows SBE to enter MOUs with municipalities who use the State's voting equipment.
- HB0839/SB0543 *Provisional Ballots Nonpartisan Board of Education Contests aka Partial Ballot Acceptance* – Effective Date: 10/1/2025 – Local boards must now count any nonpartisan contests for provisional voters who vote the wrong party ballot during a primary election. In the past, a voter who voted the wrong party's ballot in a primary election would be rejected. This bill now makes us partially count the voter's ballot for the nonpartisan contest. This means that our "in-part" provisional ballots will increase, and our rejected ballots will decrease.
- SB0308 *Election Law Chief Election Judges Party Affiliation* Effective Date: 10/1/2025 Local boards must assign a Democratic and Republican chief judge to each polling place, to the extent practicable, 45 days prior to election day.
- HB0586/SB0534 *Election Law Election Judges Compensation* Effective Date 10/1/2025 Local boards are not required to pay the \$50 training pay to individuals

who do not show up to serve as an election judge.

### Bills that did <u>not</u> pass:

- HB0317 *Election Law Curbside Voting Pilot Program* This bill would require three local boards (one small, one medium, and one large jurisdiction) to offer curbside voting.
- SB0018 *Election Law Early Voting Number of Days* This bill would reduce the number of early voting days from 8 days to 5 days.

### Maryland Association of Election Officials (MAEO)

- Conference information Sunday, May 4<sup>th</sup> to Friday, May 9<sup>th</sup> at the Grand Hotel in Ocean City. Ms. Perrone provided copies of the tentative agenda and conference information.
- SBE Biennial Sunday, May 4<sup>th</sup> and Monday, May 5<sup>th</sup>. Board members and counsel are required to attend the biennial. If you cannot attend, you must ask for an exemption from the State Administrator. Mr. Gullo has received an exemption as he will be attending to municipal elections on the same date.
- MAEO Days Tuesday, May 6<sup>th</sup> through Thursday, May 8<sup>th</sup>. There will be general sessions, but a lot of it is geared toward elections staff, not the Board.

Mr. Foster invited Mr. Gullo to continue as the counsel for the CCBOE. Mr. Gullo accepted, and the required paperwork will be processed.

Mr. Foster attended the Local Board Committee Meeting for MAEO on March 10, 2025. He shared with the board that there were around 10 people that attended in person and the rest were virtual. He provided notes from the meeting and learned that most of the boards are doing the same processes. The committee will meet quarterly.
