Unfinished Business

Mr. Watson updated the board on his communications with the Ethics Board regarding the involvement of a family member with a Carroll County candidate's campaign. He will be collaborating with Mr. Gullo and Ms. Perrone to develop a plan for the 2026 Gubernatorial Election that adheres to the Ethics Board's requirements. Mr. Watson will also be sharing the correspondence received from the State Ethics Commission with the other board members. Mr. Gullo is confident that a feasible plan can be created.

New Business

Ms. Perrone presented the 2026 Election Plan. She informed the board that the twenty-five polling places for the 2026 Gubernatorial Elections will remain the same as those used for the 2024 Presidential Elections.

The board voted to approve the polling places following a motion from Ms. Donaldson, and a second from Mr. Edelman. The motion passed unanimously. Mr. Watson abstained from the vote in accordance with ethics recommendations.

Ms. Perrone presented the plan for the early voting centers. Two of the centers, Westminster Senior Center and South Carroll Senior Center will remain the same. The Charles Carroll Community Center was proposed to replace Coppermine Pantherplex as the third early voting center. This change is being made due to ADA compliance and scheduling issues with the facility. The Charles Carroll Community Center is a county-owned facility with existing cameras in place, currently used as a polling place on election day, ADA accessible with plenty of parking and allows electioneering.

The board voted to approve the early voting centers following a motion from Ms. Donaldson, and a second from Mr. Edelman. The motion passed unanimously. Mr. Watson abstained from the vote, in accordance with ethics recommendations.

Ms. Perrone presented the plan for the ballot drop boxes. The two proposed changes

include the Board of Elections Office drop box as the office has moved to a new facility. The second proposed change is the Coppermine Pantherplex drop box will move to the new early voting center location at the Charles Carroll Community Center.

The board members expressed concern about voter confusion, and Ms. Perrone ensured that signage will be placed at the previous locations to ensure voters know where to find the ballot drop boxes.

Mr. Edelman relayed concern about taking an early voting center and a ballot drop box out of the Manchester/Hampstead area. Discussions ensued to determine what locations would be an option. After receiving correspondence from Ms. Steinbacher, Mr. Edelman suggested an additional drop box be placed at the Manchester Police Department. Mr. Watson asked what the expense would be to add an additional drop box. Ms. Perrone agreed to reach out to the Manchester Police Department to see if this location would be possible as well as contacting the county IT department regarding security cameras. She will also contact the State Board of Elections to get the cost and availability of obtaining an additional drop box.

Mr. Edelman made a motion to table the approval of the ballot drop boxes until the November 19, 2025, board meeting when further information can be provided. Ms. Donaldson seconded the motion. The motion passed unanimously. Mr. Watson abstained from the vote, in accordance with ethics recommendations.

Disclosure of Campaign Contributions

Ms. Donaldson purchased a ticket to the Lincoln Reagan Dinner for the Carroll County Republican Central Committee.

The next scheduled meeting is Wednesday, November 19, 2025, at 10 am.

Adjournment

The motion for adjournment was made at 11:05 am by Mr. Watson and seconded by Ms. Miller. The motion passed unanimously.
