#### Attorney Report

Mr. Gullo reported that the Board Attorney calls with the Assistant Attorney General and the State Board of Elections (SBE) began on Tuesday, October 4<sup>th</sup>. He will keep the Board informed if anything arises for Board discussions.

Mr. Gullo reported that he worked with Ms. Berry to have a letter that he signed on behalf of the Board sent to the State Prosecutor's Office and SBE regarding the candidate filing misinformation that was previously provided to the State's Attorney's Office. There has been no response from the State Prosecutor or SBE at the time of this meeting. Mr. Gullo stated that turning the situation over to the Sheriff would result in having the case return to the State's Attorney.

A discussion among the Board occurred. Mr. Woodley stated he spoke with Sheriff Dewees about including him in any conflicts or conversations. Sheriff Dewees welcomed any information that could be provided to him to assist with abnormalities that may occur. The Board directed Mr. Gullo to work with Ms. Berry to provide Sheriff Dewees and the incoming State's Attorney with information regarding this matter prior to the general election.

The close of registration for the general election is October 18.

#### Ballots & Mail-In Voting

Drop boxes were delivered last week and the pick-up schedule has been emailed to board members.

Ballots were put into the mail system on September 29<sup>th</sup>, so voters should start receiving their ballot this week. We were notified yesterday of an error by the mail-in ballot vendor. Some voters got an outer mail envelope with Calvert County Board of Elections in the

return address. SBE is working to determine the scope of the error and how many voters may have received the incorrect outgoing envelope.

Emergency litigation for canvassing ballots has been granted pending a court hearing on October 7<sup>th</sup>. A discussion occurred regarding setting a date to have a mail-in ballot canvass prior to election day. The Board decided not to set a date for an early canvass and asked to be notified by October 18 if an unmanageable amount of ballots are requested and returned that cannot be handled in the canvasses that are scheduled by law.

Sample ballots should be mailed within the next week.

#### Election Judges & Polling Places

Election judge training has begun. There are around 70 vacancies currently.

Exterior portable lights will be delivered to our office and Sandymount Elementary for election day.

County Payroll is helping us through a payroll discrepancy from the primary election.

Winfield Fire Department will be having a door replaced due to damage from the transportation cart.

#### IT/Warehouse

Logic & Accuracy (L&A) testing has been completed on the scanning units and ballot marking devices. The L&A Public Demonstration will occur next week.

Ballots are expected to arrive next week so that they can be packed in the transportation carts. Ballots are important to assist mail-in voters who have made mistakes on their original ballot and need a replacement ballot.

Supply verification by the Board needs to be completed by October 12<sup>th</sup>. Mr. Tegeler and Mr. Foster stated that they would complete this verification on that date.

Voting equipment is expected to be delivered on Friday, November 4<sup>th</sup> with three trucks. There will be multiple runs per truck. Ms. Berry reiterated that the transportation company follow the schedule that has been outlined. The trucks will arrive at the loading dock at 7am. Mr. Woodley, Mr. Foster and Ms. Coley volunteered to guide the trucks for the deliveries.

#### Personnel & Budget

We are working to get another grant to address some physical security enhancements.

## New Business

A troop leader from the Girl Scouts of Maryland contacted the office to ask permission to sell Girl Scout cookies at the polling places on election day if they maintained the 100' distance from the entrance of the polling place. A discussion occurred. The Board discussed a prior Board decision made several elections regarding this issue. The Board decided to continue to require the Girl Scouts to contact each of the facilities to ask the individual location's permission to be on their property.
