Call to Order & Declaration of Quorum

Mr. Foster called the meeting to order at 10:00 am and declared a quorum was present.

Welcome

Mr. Foster welcomed those in attendance and introduced the members of the public that were present.

Additions to the Agenda

Mr. Foster asked if any there were any additions to the agenda. There were no additions added to the agenda.

Approval of Minutes

The Board approved the minutes from the October 18th, 2023, meeting on a motion from Mr. Watson, seconded by Ms. Coley. The motion carried unanimously.

Public Comments

Mr. Foster reviewed the public comments policy. It is required that members of the public ask in advance to speak to the Board by emailing or calling Ms. Perrone.

Corynne Courpas, on behalf of the Carroll County Democratic Central Committee, requested to speak and followed the public comment policy. Ms. Courpas was granted three minutes to address the Board. She told the Board that Ms. Frazier invited her to join the Election Integrity Committee and stated her concerns for the ballot box collection processes. Ms. Courpas saw nothing of concern regarding the ballot box collection process but promised to discuss it with the Democratic Central Committee. Ms. Courpas expressed her concerns of national threats towards election officials.

"The CCDCC asks our Republican friends to allow this Board to concentrate on the work at hand. We believe that they will take all the necessary steps to continue their excellent performance in future elections. In our opinion, the report submitted by the CCRCC Committee is a litany of 'solutions in search of problems.' We believe that free and accessible elections followed by the PEACEFUL transfer of power, are the fundamental strength of America. We should all work together to continue that tradition here in Carroll County."

Mr. Foster and Ms. Coley thanked Ms. Courpas for her support.

Early Voting Centers/Polling Places

Ms. Perrone reported that the Early Voting Center plans were approved by SBE on October 26, 2023. Approval for the polling places is still pending and a date for this action is unknown.

Election Judges

Ms. Perrone stated that the Election Judge team is still awaiting updated tax documents and paperwork for the upcoming election from the County.

IT/Warehouse

Ms. Perrone explained that although the new pollbooks will not be used in the 2024 elections, we will continue to work with SBE to train our staff and test the functionality of the system. During the week of November 27, 2023, members of our staff will be attending a training on the new pollbooks. During the week of December 4, 2023, members of our staff will participate in testing the pollbooks and the connectivity.

Personnel

Ms. Perrone informed the Board that recruitment for the Deputy Director position closed on November 13, 2023, at 11:59 p.m. With Mr. Gullo's advice it was decided that any further questions regarding the hiring process would be discussed during a closed session. No motion was made for this matter to be carried into a closed session.

Ms. Perrone shared with the Board that office staff member Hunt Hobbs and his wife welcomed their first baby on Halloween. Adrian Hobbs weighed 7 lbs., 9oz., is healthy and the family is doing well.

The Board members were invited to join the office staff for their holiday party. This will take place on Friday, December 15, 2023, at noon. The staff decided to have a potluck where they will all bring a dish to share and the board members contributions will be put towards the main dish, paper products and beverages.

Budget/County

Ms. Perrone informed the Board on the status of the new building. During the November 2, 2023, meeting of the Carroll County Commissioners, the new building was approved and the lease was signed. Ms. Perrone is in contact with the Carroll County & SBE IT departments to get their part started as it can be a six-month lead time to get the work completed installing the T1 lines required for MDVOTERS connectivity. Ms. Coley stated that the timeline for the building completion was very close to the date of the election and asked whether we would move that close to the election. Ms. Perrone stated that a lot needs to happen between now and then and we will have to wait and see when the project is complete. We will also need to see what SBE, and the County will require.

The FY25 Budget is due on December 8, 2023, and Ms. Perrone will present to the board at the December 13, 2023, meeting. Ms. Perrone reminded the board members if requested any additions to the budget to please let her know. Ms. Coley responded that she was happy

Discussion of the Republican Central Committee's Suggestions dated September 20, 2023, and October 19, 2023

Ms. Perrone reminded the board of Ms. Frazier speaking at the last board meeting October 18, 2023. Ms. Frazier sent the Republican Central Committee's resolution on October 19, 2023, suggesting improvements that can be made to the ballot drop box procedures.

Ms. Donaldson stated she was emailed a larger selection of the *Ballot Drop-Box Integrity/Transportation Log*. She presented the forms with highlighted areas of her concern. Ms. Perrone explained on camera what they were looking at why the areas in question were not filled out. This form was on the day the drop-boxes were delivered so there were no ballots to transport. The form was acknowledging the delivery of the drop box itself. Mr. Edelman pointed out that there was nothing done wrong since there were no ballots being transported. There were areas of the form discussed where improvements could be made and recommendations for staff to be more conscientious in making notes regarding these situations.

Ms. Perrone suggested that the recommended resolutions be sent to SBE for review and to see if they would agree to any of the changes listed. Mr. Foster agreed that this was a good idea and to move forward with sending it to SBE.

Deputy Director Position

Mr. Watson asked whether it was necessary to discuss the open position for Deputy Director. Mr. Gullo was consulted about this, and he suggested to discuss in closed session. It was decided to add this discussion to the December 13, 2023, board meeting agenda.
