Mr. Foster asked if there were any correspondence to share. Ms. Perrone shared a letter from a constituent about their voting experience. Ms. Perrone has spoken with the chief judge at the early voting center as well as the voter's parents regarding their concerns.

Attorney Report

Mr. Gullo would like to make plans in the new year to go over the responsibilities of the board members and the chain of command that should be followed. Board members act as a conduit for the community and questions and the process to report a complaint needs to be consistently followed. Mr. Gullo advised the board to send any complaints, emails, or reports to Mr. Foster. Mr. Foster will then contact the Election Director.

Mr. Gullo reminded the board about same day registered voters and verifying their proof of residency during the provisional canvass. The State directed the local boards of elections to accept the provisional ballots of the voters who provided any type of proof of residency even if the person was not verified via the voter registration system. Mr. Gullo encouraged the board to think about the scenario and determine whether to follow up with the State Board.
