#### **Swearing in the Board of Canvassers**

At 10:02 am, Ms. DeWees conducted the swearing of the board members that were in attendance – Mr. Foster, Ms. Donaldson, Mr. Edelman, and Mr. Watson. Ms. Coley and Mr. Gullo will be sworn in by Ms. DeWees during a private appointment.

#### Call to Order & Declaration of Quorum

Mr. Foster called the meeting to order at 10:12 am and declared a quorum was present.

# **Additions to the Agenda**

Mr. Foster asked if any there were any additions to the agenda. Ms. Perrone announced that the board needed to vote for Chairman and Secretary of the Board of Canvassers. Mr. Gullo explained the responsibilities involved with each. Ms. Donaldson nominated Mr. Watson for Secretary and Mr. Foster seconded the nomination. Mr. Watson accepted the appointment as Secretary of the Board of Canvassers. Ms. Donaldson nominated Mr. Foster for Chairman and Ms. Coley seconded the nomination. Mr. Foster accepted the appointment as Chairman of the Board of Canvassers.

# **Approval of Minutes**

The Board approved the minutes from the March 20, 2024, meeting on a motion from Ms. Coley, seconded by Mr. Edelman. The motion carried unanimously.

## **Correspondence**

Ms. Perrone shared an article from the Carroll County Times dated March 22, 2024, with the headline "Carroll County Board of Education candidates will not be on primary ballot." Ms. Perrone also shared a statement from Maryland State Board of Elections Administrator Jared DeMarinis on the signing of the Protecting Elections Officials Act of 2024 (SB480/HB585) by Governor Moore. The last correspondence that Ms. Perrone shared was statement from the Maryland State Board of Elections announcing nearly 600,000 voters have requested mail-in ballots ahead of the 2024 Presidential Primary Election.

## **Attorney Report**

Mr. Gullo explained that he does not have any updates regarding the Memorandum of Understanding (MOU) regarding voting irregularities.

Mr. Gullo participated in a meeting with the legal counsel from the other local boards of election and the State Board of Elections. They discussed the scheduling of sports activities at some of the local polling places and how it may impact election day.

- 710 were mailed back, 406 were put in a drop box, 6 were dropped off in person;
- 2,355 were mailed back, 985 were put in a drop box, 10 were dropped off in person as of 4/16/2024
