DECLARATION OF QUORUM PRESENT

The meeting of the Board of Canvassers began at 10:49 a.m. on February 17, 2021 at 300 S. Center St, Robert Moton Room, Westminster. There was a quorum of the Board of Canvassers, and at least one member of the Board of Canvassers who is a registered voter of the principal minority party was present.

CONFIRMATION OF OATH

Heather DeWees, the Clerk of the Court for Carroll County, administered and recorded the oath of each member of the Board of Canvassers on Wednesday May 6, 2020.

APPROVAL OF MINUTES

Paula Troxell Deputy Director presented the post certification minutes from the December 16, 2020, canvass board meeting. Ms. O’Callaghan made a motion to approve the minutes. Mr. Tegeler seconded the motion, and the motion passed unanimously.

CANVASSING

Overview of Canvass Process

Katherine Berry Election Director, explained the rules concerning public observation of the canvass, stating that due to the COVID-19 pandemic, and in accordance with the Governor's Proclamation of April 10, 2020 and current social distancing guidelines issued by the Centers for Disease Control, that no more than 10 people may be in a room at once, and that all individuals must maintain a distance of six feet from each other.

Katherine Berry Election Director provided an overview of the canvassing process and noted how the ballots were determined to be untimely.

Canvassing of Vote by Mail Ballots

Paula Troxell Deputy Director reported that 1 vote by mail primary ballot was received after the certification of the primary election. Mr. Foster made a motion to reject the vote by mail ballot as being untimely. Mr. Tegeler seconded the motion, and the motion passed unanimously.

CANVASSING STATISTICS

Paula Troxell Deputy Director reported that 1 vote by mail primary ballot was presented for canvassing and 1 vote by mail primary ballot was rejected for being untimely.
