Canvass and Duplicating Team Participants

Katherine Berry noted that the teams of canvassers and duplicators have changed since the last canvass, but all members of the teams have worked in a previous canvass during this election. Canvassing of ballots resumed. All participants are election judges and were sworn in.

Printing Canvass Results

After scanning all accepted vote by mail ballots, Eduardo DeLima and Kimberly Jones locked the ballot scanners and printed an Election Results Report. Katherine Berry confirmed that the number of accepted ballots were off by two after the ballots were scanned and board decisions were removed for the June 10, 2020 canvass. 2 ballots were read twice in error when the scanning unit jammed, so 6,524 ballots were scanned and 8 ballots were pulled for the board decisions being made on June 10, 2020.
